IN 2015/16 OUR HUMANE OFFICERS RESPONDED TO 1,781 CALLS FOR HELP. 317 DOGS AND 340 CATS WERE ADOPTED, COMPLETE WITH HEALTH AND BEHAVIOR CARE, STERILIZATION SURGERY, MICROCHIPS AND TRAINING INFO. 309 LOST DOGS AND 148 LOST CATS WERE REUNITED WITH THEIR FAMILIES. KHS PERFORMED 2,471 SPAY/NEUTER SURGERIES, OF WHICH 161 WERE PROVIDED FREE OF CHARGE.


