KHS OPERATES AN OPEN-ADMISSION ANIMAL SHELTER WITH FULL SERVICES 7 DAYS A WEEK AND 24 HOUR A DAY EMERGENCY SUPPORT ANIMAL SERVICES FOR THE COUNTY OF KAUAI. IN 2021 OUR HUMANE OFFICERS RESPONDED TO 796 CALLS FOR ASSISTANCE. 673 DOGS AND 646 CATS WERE ADOPTED, COMPLETE WITH HEALTH AND BEHAVIOR CARE, AND TRAINING INFO. 355 LOST DOGS AND 58 LOST CATS WERE REUNITED WITH THEIR FAMILIES. WE ALSO EXPANDED THE TRANSFER PROGRAM, WHICH TRANSFERS DOGS AND CATS TO THE MAINLAND FOR ADOPTION FROM OTHER SHELTERS. IN 2021/2022 WE TRANSFERRED 185 DOGS AND 463 CATS.
